## PLEASE NOTE:

This is your official approval to build the above mentioned build on this block and lot. **BEFORE** actually starting this building a city building permit must be on file with PALA and all construction bond must be paid in full, along with all PALA dues and fees required. All work done in Pulu Amsic must be done in compliance with applicable building and other codes and meets all Pulu Amsic Lot-Owners Association, Inc. PALA, **PALA CONSTRUCTION RULES** and **PALA REGULATIONS**.

Hours of Construction, remodeling or otherwise noise-producing work, excluding emergency repairs, is restricted to Monday through Saturday, between the hours of 8:00 a.m. and 5:00 p.m. No work shall be permitted on Sunday's or holidays. All work done in Pulu Amsic must be done in compliance with applicable building and other codes and meets all Pulu Amsic Lot-Owners Association, Inc. by-Laws and Deed of Restrictions.

The above building site will be randomly inspected by representatives of PALA Construction Committee or Board Members and these representatives will be given full access and cooperation during the inspection to this building site.

## Note:

ALL workers will have a PALA picture I.D. on them at all times when inside the Pulu Amsic subdivision. If **NO I.D**. than entry in to Pulu Amsic Subdivision. Lost workers I.D.'s can only be replaced **ONLY** once, at a replacement cost of **500 PHP**.

I.D.'s are issued by PALA at a cost of **150 PHP** each, paid by the builder before that start of building.

IF workers fail to follow any and all of the PALA CONSTRUCTION RULES and PALA REGULATIONS they can be BANNED from any and all building sites in Pulu Amsic Subdivision.
