POLICY RESOLUTION NUMBER 2024-001

Subject: RESOLUTION TO REDUCE THE BOARD MEMBERS OF PALA FROM 7 TO 5 BOARD MEMBERS.

The adopted rewritten rules shall be in full effect from the date of this resolution until the next Annual General Meeting (AGM) scheduled for May 18, 2024, during which the members will vote on the adoption of the said rewritten rules.
