**BID AWARDING THE CONTRACT FOR THE SUBDIVISION FIBER OPTIC CCTV SYSTEM TO JY VISION, CONCEPCION, TARLAC.**

**WHEREAS**, the Pula Amsic Lotowners Association (PALA) recognizes the need to enhance security within the subdivision through the installation of a modern, reliable CCTV surveillance system;

**WHEREAS**, after careful review, the bid submitted by JY VISION, Concepcion, Tarlac, was found to be the most responsive and advantageous to the Association;

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the contract for the supply, installation, and commissioning of the Fiber Optic CCTV System for the Subdivision is hereby awarded to JY VISION, Concepcion, Tarlac, with an estimated project cost of Nine Hundred Fifty Thousand Pesos (Php 950,000.00);

**BE IT FURTHER RESOLVED**, that the scope of work shall include the deployment of upgraded high-definition cameras, with provisions for additional units to ensure full coverage of all key areas as determined during the site assessment. The system shall be integrated with a centralized monitoring station, offering real-time video feeds and secure data storage, including a monitor at the main gate covering the main boulevard;

**BE IT FURTHER RESOLVED**, that all equipment and installation practices shall adhere to the latest industry standards, ensuring reliability, scalability, and ease of maintenance. The project timeline and detailed specifications shall be finalized in coordination with the subdivision's management to guarantee minimal disruption and optimal placement of all surveillance units;

**BE IT FINALLY RESOLVED**, that this resolution shall take effect immediately upon its adoption.


